The professional code of ethics of the National Police of the Republic of Indonesia is basically a guide for all police function actors in carrying out their duties in accordance with the applicable laws and regulations in their territory. Therefore, the professional code of ethics plays an important role in realizing police professionalism. The National Police Chief has released a number of policies to improve the performance and quality of public services. One of the steps taken is to require the National Police to have and implement Standard Operating Procedures (SOPs). The SOP serves as a guideline in the implementation of tasks in accordance with the function and as a tool for assessing the performance of government agencies, by using technical, administrative, and procedural indicators that are in accordance with work procedures, work procedures, and work systems in related units. The purpose of SOPs is to create responsibilities related to the tasks carried out by government agency work units, in order to realize Good Governance. SOPs are not only internal, but also external, because SOPs can be used to measure responsiveness, responsibility, and accountability for the performance of government agencies (Destiani et al., 2023).

An orderly and safe life is the hope for every community, in carrying out daily activities without any interference from any party. A safe and orderly community environment is one of the indicators of welfare in society and can create a good life. Human beings as social beings have needs that must be met in their lives such as the need for clothing, food, security, recognition by others, and self-actualization. Such as the need for a sense of security, both physical and spiritual security, both from within a person himself and from the outside, such as the

environment, nature that must be fulfilled by the Police, in this case, its position in the middle of the community environment has an important role to create a better relationship between the Police and the community. Discretion, on the one hand, is considered to negate certainty of something that will happen, on the other hand, it guarantees legal certainty to be one of the functions of law. Discretionary actions decided by the Police in dealing with legal issues in the field directly at that moment and without asking for instructions or decisions from their superiors are discretionary in nature (Adnyani, 2021). Efforts to maintain public peace and order are carried out in the form of policies issued by Regional Heads in the form of Regional Regulations (Perda), Regional Head Regulations (Perkada), Regional Head Decrees and actions taken in urgent circumstances. Based on the Regional Regulation and Regulation, in order to maintain the existence of the implementation of public order and peace, as well as to carry out community protection, the Regional Government's task is mandated to the Pamong Praja Police Unit (Satpol PP) in the area concerned which is the starting point for coaching steps, in this case preventive for the community (Yushantini, 2020).

communication, will enable police members to be able to obtain various effective

solutions in overcoming work stress. The diversity of society has an impact on the

diversity of ways of thinking and demands for police officers' services, so that

multicultural personalities are expected to be able to understand diversity without

having to feel stress when performing their duties.

According to (Akbar & Asworo, 2019) about the multicultural personality and

effectiveness of various training programs, and conduct surveys and collect

feedback regularly from members of the police and communication to evaluate

and improve existing multicultural programs. And the public can raise awareness

about the importance of multicultural personalities in the police, and how they

contribute to safety and harmony in the community. With solutions from the

community, police members can build a solid multicultural strength within police

members, so that they are able to face challenges in a diverse environment more

effectively and efficiently.

Conclusion

The challenge of the police as an authorized institution in protecting, protecting

and serving the community in the future, which of course is increasingly complex,
